1. NAME:

That the Trust hereby established shall be in the name and style of "SRI RAGHAVENDRA CHARITABLE TRUST".

2) OFFICE:

The Registered office of the Trust shall be situated at D.No.4-154, Nimmalavari Street, Sivadevuni Chikkala, Palakole Mandal, W.G.District, A.P. and at such place/s as the Chairman may from time to time decide to open and start Branch / Administration Offices any where in India, as he/she may think proper or necessary.

3) OBJECTS:

The aims and Objects of the Trust shall be as under:

4. DONATIONS:

The Founder may accept on behalf of Trust and donations or contributions in cash or kind or any property movable or immovable within India or Abroad, from Person/s firms, bodies, corporate or incorporate for the furtherance of the object of the Trust.

That the properties of funds recovered by the Founder in the name of Trust. That the funds which are received by the Trust as Voluntary contributions shall be invested or spent in a manner prescribed by law governing such investments or expenditure.

That the Trust shall meet the expenses for the administration and management of the Trust besides spending for the objects of the Turst.

It is further provided that no part of the income of the Trust should be directly or indirectly applied for the benefit of the Trustees (as specified by Income Tax Act, 1961).

5. BOARD OF TRUSTEES:

The Board of Trustees shall consists of 5 (five) members i.e., one founder Trustee, one Secretary Trustee, one Treasurer Trustee and Three Trustee members. The Trust Board shall meet atleast once in a year or on the date notified by the President for taking necessary decisions and reviewing the activities of the Trust. A meeting of the Trust shall be entitled to execute all and of the powers vested in the Trustee under these presents of law. The minutes of the proceedings of every meeting of the Trustee shall be entered in a book to be kept for that purpose and signed and shall be conclusive evidence of the business and other matters conducted and such meetings.

- 15.7. To incur all expenditure necessary or in their opinion useful for carrying out the objects of the Trustee.
- 15.8 To enter into contracts with any person or body or for any purpose or purposes.
- 15.9 To sell, lease or otherwise dispose of any immovable properties, assets and goods of the Trust.
- 15.10 To employe necessary staff considered useful for carrying out the objects of the trust.
- To mortgage or charge any property or asset. movable, immovable of the Trust or vested in the trustee in favour of the government or any other department in pursuance of the rules of the government or any department thereof.

To frame rules and byelaws for the conduct of the business of the Trust and of its transactions and of the Committee of Management and to determine who shall be entitled to operate on the bank account/accounts of the Trust and draw cheques thereon.

The Trustees may borrow any such cum or sums of money that they may think necessary for the purpose of the Trust on such terms and conditions as they may deem fit. The Trustees borrow from central /State Financial insitutions, Body corporate, Nationalized / Scheduled Banks, Co-operative Banks, other Government / Non-Government Agencies both within Indian or abroad for attainment of its objectives with or without security of the movable/immovable properties of the Society/self help Groups, by way of mortgage, Hypothecations, lien pledge of its funds placed in fixed mortgage, hyphothecations, lien, pledge of this funds placed in fixed deposits or in any form as required by the lending Institutions.

(18) REIBURSEMENT OF EXPENSES:

The Trustees may reimburse themselves and pay and discharge out of the Trust fund all expenses incurred in out about the execution of the Trust or any founder objects of Trust or any of their duties under these present. The Trustees shall be indeminified by the Trust properties against consequences of all lawful fine by the Trustees in the course of and discharge of their duties as the Trustees of these trust and costs charges and expenses thereof.

(19) LEGAL MATTERS

The Founder opinion shall have power to institute suits, claims or other proceedings and to compromise or compound actions, suits and other proceedings and all differences and disputes touching the Trust properties and to adjust and settle all accounts relating to the Trust properties and to do all other acts and things as if the Founder was absolutely entitled to the trust properties.

(20) DISSOLUTION:

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees / members of the Managing Committee / Members of the Governing Boy, but the same shall be transferred to another trust whose objects are similar to those of this Trust and which enjoys recognition under section 80-G of the Incom Tax Act, 1961.
